ConnecTAX Invoice zoom

Would you like to control the invoicing information that the tax authority sees about you and know to what extent these match the data reported and registered by the company? Would you like to monitor if there is a difference between the information in your own invoicing systems and the ones stored at HU TA and if yes, at which points the information differs? You can do all of this in an automated manner with the help of our Invoice Zoom service.

HOW DOES INVOICE ZOOM HELP YOU?

With the help of our solution, our partners can simulate an invoicing data audit by the tax authority and can check at discretionary frequency the invoicing data submitted to the tax authority by multiple invoicing systems also. Checks cover both invoices subject to reporting obligation and the ones not included in this circle but representing VAT obligation. In addition, companies can rely on the control module as an internal control before the preparation of tax returns.

The solution allows companies to identify the problems that may pose a tax risk in the case of a tax authority audit. Invoice Zoom gives a clear picture of the invoices:

- to which reporting obligation applies but were not reported or the reporting of which failed due to an error,
- which were subsequently invalidated and not reported again or their re-reporting failed,
- which were reported but, for some reason, are included with different data in the company's internal database and the tax authority's database,
- which were reported to the tax authority but are not included in the invoicing programs.

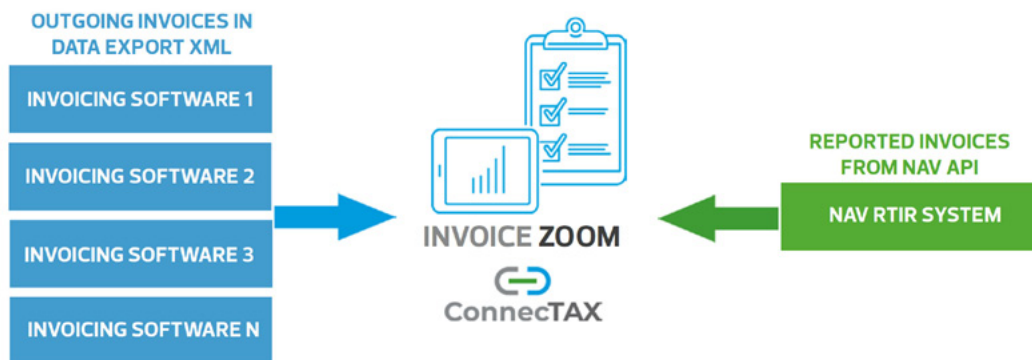
HOW DOES INVOICE ZOOM WORK?

The program runs an automated check in which the data stored in the invoicing programs is compared to the data reported to and included in the system of HU TA as outgoing invoice data. The check can be started automatically without manual intervention at discretionary frequency (hourly, daily, weekly etc.).

The system gives notices of potential differences of the invoicing data of the company concerned and the data of HU TA and is able to simulate a tax authority audit. With timely correction of data, companies can efficiently reduce the risk of invoice reporting penalty of up to 500 thousand forints per invoice.

TO WHOM DO WE RECOMMEND THE INVOICE ZOOM MODULE?

- Companies having a high volume of outgoing invoices
- Companies having invoicing data reporting obligation
- Companies preparing monthly, quarterly VAT analytical records and VAT returns
- To support tax compliance functions



TECHNICAL REQUIREMENTS

The use of the software is based on the compulsory data reporting functions prescribed by legal regulations. The invoicing program(s) covered by the analysis must have the data export function prescribed for the submission of data to the tax authority.

No further programs have to be installed and no further settings are required in the invoicing system, only the XML data files generated need to be uploaded to the storage space of ConnectTAX FTP. In addition, a HU TA technical user with the appropriate authorizations is also necessary for the service.
